



## LITTLE THEATRE PLAY TONIGHT

Tonight and Saturday night the Hampton Little Theatre will present "Another Part of the Forest" at the Hampton High School auditorium. ## FACTS ABOUT STATE TAX

### PERSONAL EXEMPTION

Unmarried person, or married person not living with husband or wife, \$1,000; husband and wife living together on December 31, 1948, \$2,000; widow or widower with dependent minor child, \$2,000; taxpayer who has had dependent upon him and who has entirely supported during taxable year a person bearing relationship to taxpayer of father, mother, son, daughter, sister, or brother, \$2,000. Where separate returns are made by husband and wife, the personal exemption allowed upon each is \$1,000. For each person dependent upon and entirely supported by taxpayer throughout 1948, personal exemption is increased by \$200, except that taxpayer entitled to claim exemption of \$2,000 can only claim the \$200 additional for each dependent (including wife or husband) in excess of one.

# STATE TAX

(Continued from page 1)

## FILING

All State Tax Returns shall be filed on or before May 1, 1949, with the Commissioner of Revenue, for the County or City in which you reside.

## DEDUCTIONS

In taking deductions on the State return, all items must be individually explained in the proper schedules. No established percentage of your income is permitted in lieu of itemized deductions as in the case of Federal income tax returns. Personal, living, or family expenses are not deductible.

Certain items of deduction are permitted by the State which is not true in the Federal return, such as fire, casualty and tornado insurance premiums in connection with property, which includes automobiles. However, in the Federal return the taxpayer is permitted to deduct all the medical expenses in excess of 5% of the adjusted gross income, with limitations, and certain other deductions, whereas the State permits no medical deductions.

Deductible taxes paid do not include State and Federal income, luxury, or amusement taxes.

Interest paid for various reasons does not include carrying charges on the purchase of household furnishings, automobiles, or other installment buying unless the sales contract stipulates that interest is being paid.

Contributions claimed must not exceed 15% of your net income, computed without benefit of this deduction.
